Scholarship Description

The Portland-area student selected as the winner of the PSF Winter Grand Scholarship receives the use of a new Yamaha grand piano in their home for two years, with piano moving, annual tuning, and maintenance costs included. At the end of the two-year term, the piano passes on to the next scholarship recipient. Grand Scholarship recipients are required to perform at all PSF events, as well as adhere to other responsibilities outlined in the <u>Grand Scholarship Agreement</u>, <u>Participation and Policy Statement</u>, and <u>Release of Liability</u>. The Grand Scholarship may also offer other performance opportunities in the community.

| January 17, 2022 | Notification to applicants. Applicants selected to perform for the music jury will be notified by e-mail with the location, date and time of their audition. Applicants that were not selected will be notified by mail only. | | | | |

| | Due to safety concerns related to the pandemic, it may be necessary to modify the format for the auditions. This may include recording live auditions with remote adjudication or the use of video submissions. Selected applicants will receive more information on the audition format no later than January 17. | | | | |
| February 21, 2022 | Notification to interview finalists. In-home interviews will be scheduled with the finalists. Interviews are conducted by the Piano Santa Foundation Scholarship Committee. The Piano Santa Foundation may request these interviews to be held remotely through Zoom, Facetime, or other video conference application. | | | | |
| March 15, 2022 | Notification to PSF Grand Scholarship winner. Scholarship contracts and other paperwork will be finalized after notification. Arrangements will be made to deliver the piano upon completion of scholarship paperwork. | | | | |

PSF's goal is to select the scholarship recipient who will receive the most benefit, both musically and personally, from the use of the piano and who will serve as a role model through participation in the PSF program.

Notification to students advancing in the process occurs by e-mail, phone, or mail on or before the dates specified. All decisions of the jury and the PSF scholarship committee are final.

Qualification Criteria

- 1. Student resides in one of the following cities: Portland, Lake Oswego, Maywood Park, Beaverton, Milwaukee, Aloha, Fairview, Gresham, Happy Valley, King City, Oregon City, Tigard, Wilsonville, Wood Village, West Linn, Tualatin, Troutdale, Damascus, Hillsboro, or Vancouver.
- 2. Student must be at least twelve (12) years of age and no older than a junior during the 2022-23 school year.
- 3. Student should be playing at an upper-intermediate to advanced skill level. For example, student should have passed Syllabus level 7 or equivalent. Student does not need to participate in Syllabus to apply.
- 4. Student must be actively enrolled in individual piano lessons for the duration of the scholarship period.

Please fill out the Application completely, correctly, and truthfully. Upon review, if there is any incomplete or missing information, the Piano Santa Foundation will attempt to contact you.

Instructions

Assemble the items below and make two copies. Maintain one copy for your files and mail the other copy to the Piano Santa Foundation along with page 1 of this application.

- 1. <u>Student Letter</u> A one- or two-page letter written by the student which describes their interest in music and the piano. This letter should also include:
 - Music education history (i.e. when the student started playing piano, how many piano teachers the student has had, any other instruments the student plays);
 - How the student would benefit by having the use of a grand piano;
 - Goals in the area of music and piano.
- 2. <u>Parent / Guardian Letter</u> A one-page letter from the parent or guardian describing the nature of music in the home and support of the student's learning process.
- 3. <u>Piano Teacher Recommendation</u> A one-page letter written by the student's piano teacher commenting on:
 - Student's study habits, progress to date, and motivation to learn;
 - Level of music student is currently studying;
 - How the teacher feels the scholarship will benefit the student.
- 4. <u>Indicator Number</u> Provide indicator number in a sealed envelope. Determine indicator number by dividing gross income from your most recent federal tax return by number of people living in household full-time (For example, in a household with a gross income of \$75,000 and three full-time household members, the indicator number is \$25,000.). Include only the indicator number in the envelope.
- 5. <u>School Transcript</u> School transcript should include the student's academic record for the most recent term of school.
