Benefits of the Grant

- Use of a piano from PSF's fleet for a minimum of one year after which Recipient can request annual extensions of the Community Placement Grant.
- Annual piano tuning and maintenance as necessary throughout the term of the grant.
- Access to the PSF music library with over 1,500 books and sheet music.

Expectations of Grant Recipients

The Recipient must not discriminate on the basis of race, color, religion, creed, sex, gender, gender expression, age, national origin, disability, marital status, sexual orientation, pregnancy, or military status, in any of its activities or operations.

The Recipient will offer music education, music therapy, or other music-related programs.

The Recipient actively works to support children of low-income or underserved populations in the Portland metro area.

The Recipient must not use the PSF piano directly to generate profit.

As part of a request for an extension of the Community Placement grant, the Recipient must send a report to PSF every year addressing the piano's condition, use, and benefit.

The Recipient must acknowledge PSF on their website.

A contract that covers the legal, insurance and ownership details must be signed after the grant is awarded and before the piano is delivered to the Recipient.

The Recipient must be located in one of the following cities: Portland, Lake Oswego, Maywood Park, Beaverton, Milwaukie, Aloha, Fairview, Gresham, Happy Valley, King City, Oregon City, Tigard, Wilsonville, Wood Village, Wet Linn, Tualatin, Troutdale, Damascus, Hillsboro or Vancouver
